CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT

I, the undersigned, hereby agree, in connection with any projects booked or related to Envision Casting, that my engagement in connection is conditioned on and subject to my adherence to the following confidentiality and non-disclosure requirements:

- a. **I will not take any unauthorized pictures**, still or moving; or make any unauthorized recordings of any cast, crew, crewmembers, sets, costumes or other materials.
- b. **I will not directly or indirectly disclose to any person or entity (including, without limitation, to any member of the press, on blogs, Twitter, Facebook, You-Tube, My-Space or any other social networks, websites or the internet) any information** of any kind relating to or concerning the Picture, Artercraft Productions, Inc. or any of its affiliates (collectively, "Company"), the screenplay or the plot, or any elements thereof (including, without limitation, call sheets, the budget, the shooting schedule, wardrobe, art department designs, props, etc.), and any activities of or information about the cast, crew and any other persons, as all such information is strictly confidential. If my position is subject to the terms of a collective bargaining agreement, the foregoing shall in no way affect my right to communicate directly with my union representative(s) regarding the terms and conditions of my employment covered by the collective bargaining agreement.
- c. **I will not bring any unauthorized guests on the set** (it being understood and agreed that I am responsible for insuring any of my authorized guests adhere to the terms of this confidentiality and non-disclosure agreement).
- d. **I will take appropriate measures to safeguard any confidential materials** I am provided in regards to the Picture, including but not limited to password protecting computers and mobile devices which carry confidential material, and never leaving confidential material (including laptops and scripts) unattended.

I understand and agree that any breach or attempted breach of the foregoing representations shall constitute a breach of this Confidentiality and Non-disclosure Agreement and will cause Company irreparable harm, not readily measurable in money.

I further understand and agree that violation of this Confidentiality and Non-Disclosure Agreement shall be cause for my immediate termination (which termination includes termination of any compensation owed to me, but not yet accrued in connection with the Picture, if applicable) and my prompt removal from the production facilities. The Company agrees that any dispute relating to such termination shall be subject to the grievance/arbitration procedure of the applicable collective bargaining agreement, if any.

Company shall have the right to take all other measures necessary to protect its rights, including without limitation, the right to seek civil and criminal penalties. Further, Company shall have the right to all other remedies at law and in equity, including injunctive relief.
